WE ARE FOCUSED ON BUILDING PATHWAYS FOR PEOPLE IN WESTERN PA WHO HAVE SUFFERED SCIS TO ACHIEVE THEIR OPTIMAL RECOVERY AND MINIMIZE THE LIFETIME FINANCIAL BURDEN, WHICH IS ESTIMATED TO COST \$2.35 MILLION PER PATIENT. THE PROGRAM WILL ENABLE INDIVIDUALS WITH SCIS TO BE PRODUCTIVE, INDEPENDENT ADULTS REGARDLESS OF TYPE OF INSURANCE OR BANK ACCOUNT. THE PILOT PROGRAM WILL BE LAUNCHING IN 2022. CURRENT FUND PROJECTS INCLUDE RYAN TIME, WHERE RYAN SHAZIER MEETS WEEKLY, ONE-ON-ONE, WITH INDIVIDUALS WITH SCI, #SHALIEVE STORIES, WHERE INSPIRING STORIES OF THOSE LIVING WITH SCI ARE TOLD.
