MAY 1, 2022 THE FUND LAUNCHED THE GOLDEN WINDOW PILOT PROGRAM FOR 10 PEOPLE WITH SCI IN ALLEGHENY AND WESTMORELAND COUNTIES. THE GOLDEN WINDOW PROGRAM ALLOWS INDIVIDUALS WITH AN SCI TO APPLY FOR UP TO \$15,000 IN DIRECT TO VENDOR SUPPORT FOR VARIOUS ITEMS INCLUDING BUT NOT LIMITED TO HOME MODIFICATIONS, ADAPTIVE VEHICLES, DURABLE MEDICAL EQUIPMENT AND SUPPLIES, AND ADDITIONAL REHABILITATION SESSIONS. THE PILOT PROGRAM HAD ACCEPTED ALL 10 PARTICIPANTS BY LATE JULY 2022.
